Day Camp Policy and Information

Camp Good News® is a non-denominational Christian camp. Its purpose is to provide clean, wholesome recreation and to give each camper an opportunity to know Jesus Christ personally and then to disciple the camper in a daily walk with the Lord. We appreciate you selecting Camp Good News for your child. The camp is located at **120 Twin Lakes Road, Hawthorne, FL 32640**. If you have any questions please call us at **352-481-3550** or the CEF® office at **352-378-0949**.

Pricing: There is an annual registration fee of \$15, which should be included when you send in this registration. The daily rate for your child is \$22 per day, or \$85 per week pre-paid.

What to bring: Please be sure to send your camper with a swimsuit, towel and bag lunch daily. Shoes and shirts are required, except for swim time. (Closed shoes are preferred because they are safer during activities. Flip-flops are recommended for swim time.) Please LABEL all your child's belongings. **A good attitude and a willingness to follow instructions go a long way to enhancing everyone's camp experience.**

What not to bring: No knives or guns (pretend or real) and other items at the discretion of the camp staff should be brought to camp. CGN will not be responsible for loss or damage to any valuables brought to camp.

Lunch: Each camper should bring their own lunch; multiple drinks would be beneficial. We recommend common lunch boxes clearly marked with child's name. Please include a cold/ice pack as necessary.

Dress Code: Attire should be modest. Discretion should be used so that wording and pictures on T-shirts and hats are in good taste and not deemed to be offensive to other campers. CGN staff reserve the right to require campers to change unacceptable clothing or to wear a shirt at swim time.

Canteen: All monies should be turned in at sign in at the bus stop or the camp to minimize the possibility of lost or stolen funds. Chips, cookies, drinks, ice cream, etc are available on a rotating basis. We will limit your child's purchases to a maximum of \$2.50 per day.

Missionary Offering: We will be presenting information about selected missionaries during camp. We will encourage your child to participate by contributing towards this project, however this is strictly voluntary.

Medications: All medications must be turned in at check in. They must be in their original containers with labels and directions attached and names clearly marked.

Photos/ Video: Any photos/videos taken at camp may be used for promotional materials.
